The 2026 – 2027 school year billing cycle will begin on July 1<sup>st</sup>, 2026. Automatic withdrawal is required for Tuition and Incidental Billing.

**SEAT FEE:** A \$500 non-refundable seat fee per child is required upon enrollment packet submission, and then annually as part of the Continued Enrollment policy. The Seat Fee is applied, in full, to the 2026-2027 tuition.

**FUNDRAISING COMMITMENT:** Each family with students in Preschool through Grade 8 is required to fulfill an annual \$600 fundraising commitment. This obligation must be satisfied through one of the options outlined below.

**\*\*This is the only required fundraiser for the school year. All other fundraisers are voluntary.\*\***

Preschool and Pre-K families who do not have older children enrolled at the school will have a prorated fundraising commitment based on the number of registered attendance days, as follows:

- **3 Days:** Sell 15 calendars (\$300 obligation)
- **4 Days:** Sell 25 calendars (\$500 obligation)
- **5 Days:** Sell 30 calendars (\$600 obligation)

**Option 1 – Participate in the Calendar Fundraiser:** Families who choose to sell calendars must submit payment at the time the calendar stubs are returned. Any stubs submitted without accompanying payment will be billed through FACTS Incidental Billing.

**Option 2 – Opt-Out Option:** Families who choose not to participate in calendar sales, and instead prefer to have the obligation billed directly, will be assessed the full \$600 fundraising fee, or the applicable prorated Preschool/Pre-K amount, through FACTS Incidental Billing. This charge will be posted to FACTS accounts on December 1, 2026.

Regardless of participation in the calendar fundraiser, each family remains responsible for fulfilling the full annual fundraising commitment (or applicable prorated amount).

**MID-YEAR TUITION PAYMENT REQUIREMENT FOR JANUARY READMISSION:** One half of the “full tuition amount” must be paid by December 1st, 2026, for students to be readmitted to the school in January 2027.
